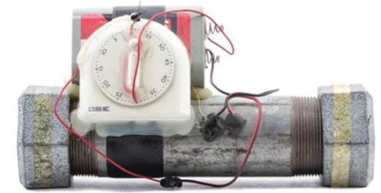




# Counter-Improvised Explosive Device (C-IED) Training

CISA OFFICE FOR BOMBING PREVENTION

The Cybersecurity and Infrastructure Security Agency's (CISA) Office for Bombing Prevention (OBP) develops and delivers a diverse curriculum of **Counter-Improvised Explosive Device (C-IED) Training** to build nationwide C-IED core capabilities and enhance awareness of terrorist threats. CISA OBP is accredited by the International Accreditors for Continuing Education and Training (IACET) and is authorized to issue IACET continuing education units (CEUs). All training is provided free-of-charge.



## Available In-Person or Online

Bombing Prevention training is offered through multiple platforms to meet stakeholder needs:



**Instructor-Led Training (ILT)** - Courses are conducted in a traditional classroom setting at your location or in-residence at the Federal Emergency Management Agency's (FEMA) Center for Domestic Preparedness (CDP). For more information: <https://tripwire.dhs.gov/training/836>



**Virtual Instructor-Led Training (VILT)** - Online training with a live instructor using the Homeland Security Information Network (HSIN) Adobe Connect platform. For more information: <https://tripwire.dhs.gov/training/381>

## Course Offerings:

Courses cover the bombing prevention spectrum and are organized into three levels of instruction:

### AWARENESS

- **AWR-333:** IED Construction and Classification (VILT)
- **AWR-334:** Introduction to the Terrorist Attack Cycle (VILT)
- **AWR-335:** Response to Suspicious Behaviors and items (VILT)
- **AWR-337:** IED Explosives Effects and Mitigation (VILT)
- **AWR-338:** Homemade Explosives and Precursor Awareness (VILT)
- **AWR-340:** Protective Measures Awareness (VILT)
- **AWR-341:** IED Awareness and Security Procedures (IST)
- **AWR-348:** Bombing Prevention Awareness Course (ILT)
- **AWR-349:** Homemade Explosives and Precursor Chemicals Awareness for Public Safety (IST)
- **AWR-903:** Bomb Threat Preparedness and Response (IST)
- **AWR-911:** Bomb-Making Materials Awareness Your Role (IST)

### MANAGEMENT

Courses are available online, taught around the United States by a national mobile training team, or held in-residence at FEMA's CDP in a traditional classroom setting; some include hands-on exercises. Courses range in length from 30–90 minutes for online awareness trainings designed to be taken individually or 1–3 days for in-person groups from 25–250 participants.



## Audience

Coordinated through Homeland Security officials and state training offices, CISA OBP courses educate federal, state, local, tribal, and territorial participants, such as municipal officials and emergency managers; state and local law enforcement and other emergency services; and critical infrastructure owners, operators, and security staff on strategies to prevent, protect against, respond to, and mitigate bombing incidents.



## What You Need to Attend or Host

- A FEMA Student ID (FEMA SID) is required to participate in CISA OBP course offerings. To obtain a FEMA SID, visit <https://cdp.dhs.gov/femasid/>.
- For mobile trainings, a local venue with a classroom large enough for registered participants, a projector and audio/visual capability, and an area capable of supporting practical exercises may be required.
